

## Tax Collection & General Information

**Taxes are due by January 31<sup>st</sup>, 2019, either in full or first half.** Make payment to: **Town of Baldwin**. If mailing, send to: *Town of Baldwin, Ronda Helgeson, 2533 County Rd E, Woodville, WI 54028*. Include a self-addressed stamped envelope if you would like a receipt sent to you. If paying half by January 31, second half is due to St. Croix County Treasurer by July 31, 2019. I will collect taxes at the Town Hall, 2399 90<sup>th</sup> Ave, Baldwin, on these dates:

**NEW THIS YEAR:** To reduce costs, the Tax Roll list is not being mailed. Options to get a copy: send me a request by mail with a self-addressed stamped envelope; pick up a copy at the Town Hall on tax collection dates; view on our upcoming website. *A website is being developed for the Town of Baldwin, which should be ready early January!* The Website address will be posted at the town hall.

**NOTICE FROM ST. CROIX COUNTY:** Effective Jan. 1, 2019 business hours of the Government Center will change to **8 A.M. – 4:30 P.M.**

**INFO FROM WI TOWNS ASSOCIATION:** Section 346.94(5), Wis. Statute states that no person may place or cause to be placed upon any highway any substance that is or may be injurious to any vehicle. A pile of icy, packed snow fits that description. Section 346.95(3) states that the penalty is \$50 for each offense. Wis. Statute 86.022 makes it a misdemeanor punishable by fine to place any obstruction in a road ditch. This means property owners should not be filling town ditches with compacted snow that will not allow drainage.

**INFO REGARDING DOGS:** State of Wisconsin requires that ALL dogs must be licensed and vaccinated for rabies. Dog license fees remain the same: \$10.00 for male or female, \$5.00 if neutered or spayed. Tags are required to be attached to your dog's collar!
