**Taxes** are due by January 31<sup>st</sup>, 2020, either in full or first half. Make payment to: **Town of Baldwin.** You can mail your tax payment to: **Town of Baldwin, Ronda Helgeson, 2533 County Rd E, Woodville, WI 54028.** If you would like a receipt, Include a self-addressed stamped envelope. If paying half by January 31, second half is due to St. Croix County Treasurer by July 31, 2020. If you'd like to pay in person, I will collect taxes at the Town Hall, 2399 90<sup>th</sup> Ave, Baldwin, on the following dates:

**REMINDER**: The Tax Roll list is no longer mailed. You can print it here from our website; 2) send a request to me by mail with a self-addressed stamped envelope; or 3) pick up a copy at the Town Hall on tax collection dates or at Town Board meetings.

**DOG LICENSE INFORMATION:** State of Wisconsin requires that ALL dogs must be licensed and vaccinated for rabies, and you need to provide a copy of the rabies certificate when licensing your dog, unless we have a current unexpired certificate on file already from the previous year. License fees remain the same: \$10.00 for male or female, \$5.00 if neutered or spayed. Tags are required to be attached to your dog's collar! **New this year:** The Town Board established a late fee, which doubles the cost if your dog is not licensed by January 31<sup>st</sup> each year.
